## **About the University**

The Thiruvalluvar University was established in Vellore district of Tamil Nadu by the Government of Tamil Nadu in October 2002 under the Thiruvalluvar University Act, 2002. The University was named after the great Tamil Saint poet "Thiruvalluvar".
