2. The vehicles will be available for inspection (all working days) between **10.30 A.M to 5.00 P.M. from 03.07.2024 to 16.07.2024** in the presence of the University Campus, Thiruvalluvar University, Serkkadu, Vellore-632 115.
3. A Disposal of goods, the **VEHICLE CONDEMNATION COMMITTEE** of the Thiruvalluvar University, **will have price negotiation with the H1 Firm** (Highest rate quotation).
4. The delivery of the auctioned vehicle will be arranged only after the successful firm/or Persons submits documentary evidence in support of residential status(Pan Card, GST, Aadhar Card etc., incase of individual and Registration Certificate etc., in case of firms.)
